PADDLER WAIVER AND RELEASE OF LIABILITY – ADULT CREWS

In consideration for being allowed to participate in the Hawaiian Canoe Racing Association and the Queen Lili'uokalani World's Largest Long Distance Canoe Races, sponsored by Kai 'Opua Canoe Club and sanctioned by Moku O Hawaii Canoe Racing Association and its member organizations' athletics/sports programs, and related events and activities, the undersigned acknowledges and agrees to the following:

- 1) That I will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.
- 2) That I knowingly and freely assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- 3) That I release, waive, discharge and covenant not to sue the Hawaiian Canoe Racing Association, Moku O Hawaii, Kai 'Opua Canoe Club, its member associations, its affiliated clubs, their respective administrators, directors, agents, coaches and other volunteers or employees, if any, of the organizations, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises or any equipment used to conduct the event, all of which are hereinafter referred to as "releases" from demands, losses or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of releases or otherwise.

EACH OF THE UNDERSIGNED HAS READ THE ABOVE WAIVER AND RELEASE, AND UNDERSTANDS THAT HE/SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGNS IT VOLUNTARILY.
