MINOR WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the Hawaiian Canoe Racing Association and its member organizations athletics/sports programs, and related events and activities, the undersigned:

1. Agrees that prior to participating, the undersigned will inspect the equipment to be used, and if the undersigned believes anything is unsafe, he/she will immediately advise the Kai 'Opua Canoe Club or club owner of the canoe of such condition(s) and if non-repairable will refuse to allow the minor to participate.
2. Acknowledges that the minor is not less than 15 years of age nor more than 17 years of age on August 31, 2008 and fully understands that the participant will be engaging in an activity that involves risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.
3. Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death.
4. Releases, waives, discharges and covenants not to sue Hawaiian Canoe Racing Association, its member associations, its affiliated clubs, their respective administrators, directors, agents, coaches, and other volunteers or employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.

THE UNDERSIGNED, CUSTODIAL PARENT OR GUARDIAN, HAVING READ THE ABOVE WAIVER AND RELEASE, UNDERSTANDS THAT HE/SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGNS IT VOLUNTARILY.
